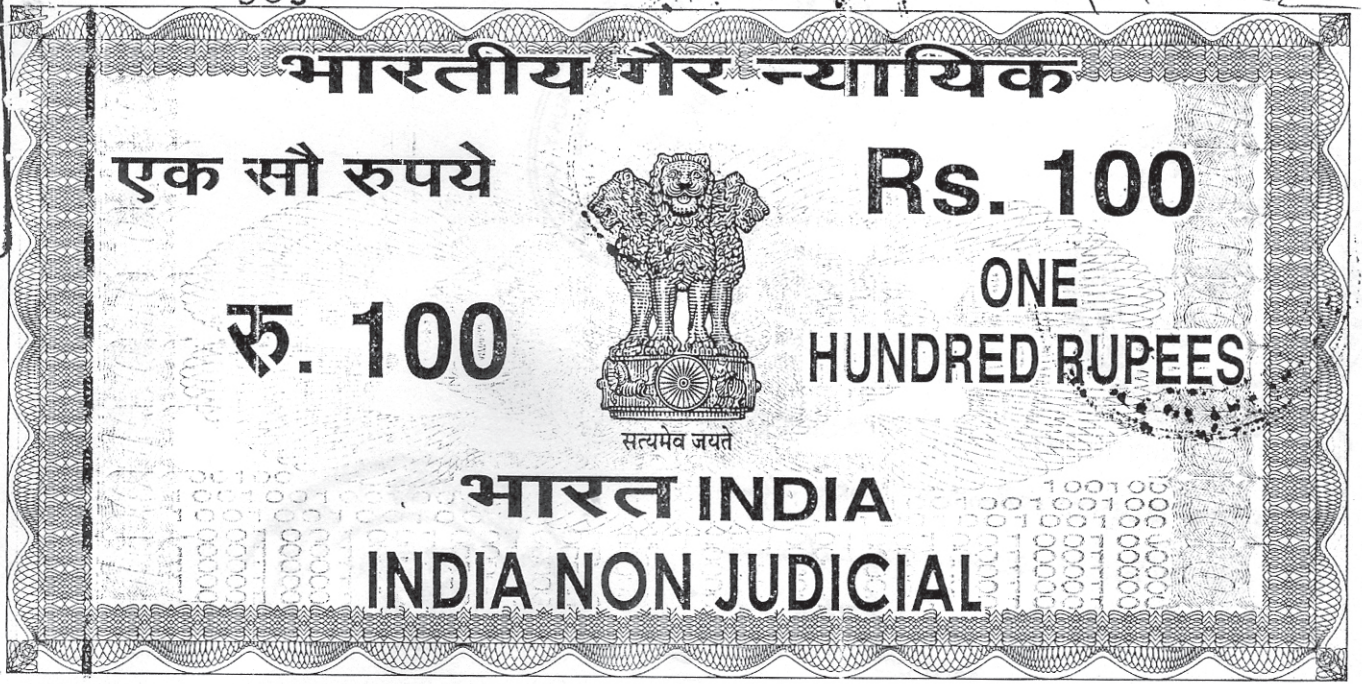

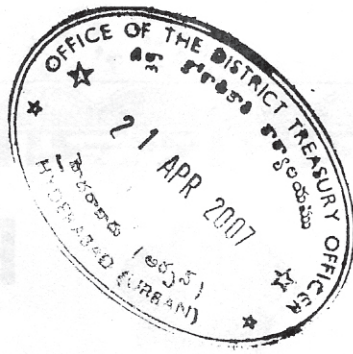

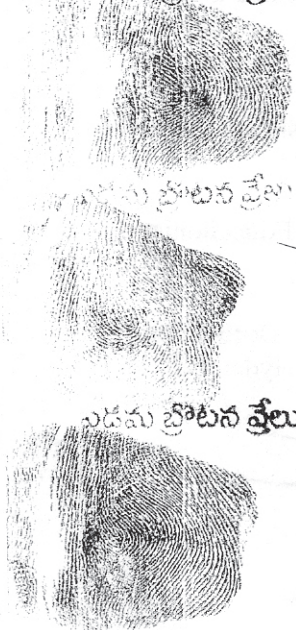

WHEREAS in the principal Trust Deed certain omissions have taken place and they have to be supplied / rectified by this Amendment to the Trust Deed.

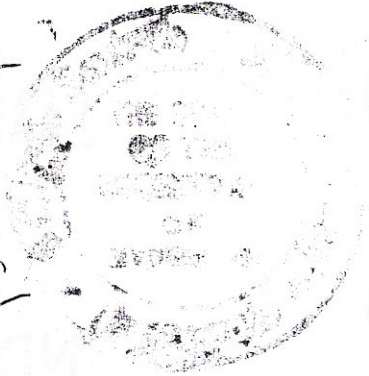
