- C) Any of members of the Trust Board may be expelled or removed from the office if the commission or part of such member is found to be detrimental or likely to be detrimental to the interest of the Trust.
- D) Any member of the Trust Board shall cease to be a trustee in case he/she
  - I) is declared to be an insolvent, or
  - II) is found of unsound mind.

05. POWER AND FUNCTIONS OF THE BOARD OF TRUSTEES:

- A) The Board of Trustees shall have all such powers to carry out such acts, commissions or omissions in order to further the aims and objects of the Trust.
- B) The CHAIR PERSON of the Board of Trustees shall be the Managing Trustee and he shall be the executive head of the Trust in accordance with the provisions of this declaration. She/he may delegate such power or responsibilities to any or more of the managing trust in matters relating to the affairs of the Trust.
- C) All the trustees shall function as honorary members and shall not be paid salary or remuneration for the work done by them on behalf of the Trust. They shall, however, be eligible to be indemnified for such expenses and costs incurred while fostering their functions as trustees.






06. **CHAIRMAN OF THE MEETING:**  
The Chair Person and Managing Trustee of the Trust shall be the CHAIR PERSON of the Trust.
07. **MINUTES:**  
The Proceedings of every meeting of the Board shall be recorded in a minutes' book maintained for the purpose. All such minutes shall be read out for consideration of the following board meeting for approval found fit.
08. **PROPERTIES AND FUNCTIONS OF THE TRUST:**  
A) The AUTHOR of the Trust, Mrs. MANTENA ROHINI VARMA, has set apart an amount of Rs.5,000/- (Rupees Five Thousands) only from her own funds towards "CORPUS" of the Trust.

C) Funds of the Trust shall be deposited in any account/s of Bank or Banks, as resolved by the Board of Trustees, held in the name of Trust.  
D) The funds and income of the Trust shall be spent exclusively for the attainment of the aims and objectives of the Trust and no portion thereof, other than the salary or remuneration mentioned in Item No.5 C) above, shall be paid, transferred or diverted, directly or indirectly to any of its members through any means.
09. **BANK ACCOUNTS:**  
Any Account or Accounts be opened in any Bank in the name of the Trust and such accounts shall be operated by the Chair Person and Managing Trustee of the Trust.
10. **BORROWING POWERS:**  
Borrowing may be made, considering the feasibility and the capacity of the Trust for the repayment thereof, for attainment of objectives of the Trust.
11. **ACCOUNTING PERIOD:**  
The Accounting Period of the Trust shall be the financial year commencing from the first day of April of every year closing on the Thirty First day of March of the immediately succeeding year.
12. **AUDIT:**  
The Books of Accounts of the Trust shall be duly audited by a Chartered Accountant appointed by the Board of Trustees.
13. **AMENDMENTS:**  
Any addition, alteration, amendment, modification to this declaration of the Trust may be made by the Board of Trustees.




